



This correspondence refers to the telephone discussion between you and Walt Guggenheimer of my staff regarding the proposed modifications of the groundwater monitoring program at the Tuba City Unified School District's bus barn.

EPA supports the proposed quarterly sampling modifications indicated in your letter, dated September 7, 2005, which recommended sampling only MW-1, MW-5, MW-6, MW-9, MW-11 and MW-12, and the installation of two new monitoring wells (southwest and southeast of MW-11) to investigate the extent of the contaminant plume.

The next round of groundwater sampling is scheduled for this month. Please submit the quarterly groundwater monitoring report for this sampling event within 30 days of your receipt of the analytical data. Please call Walt Guggenheimer at 415-972-3377 if you have questions or need more information.
