This correspondence refers to the tank closure reports dated July 15, 2003, that were prepared by Ironhorse Environmental Services, Inc. for the White Cone Trading Post in White Cone, Arizona and the abandoned Bitahochee Trading Post in Bitahochee, Arizona. Both sites are located on land of the Navajo Nation.

The analytical results for soil samples collected at the UST sites indicate no hydrocarbon concentrations above appropriate EPA, Region IX soil cleanup levels. The information submitted has assisted EPA in assessing the status of these sites, where two USTs were removed at each location on April 18, 2003. Based on the analytical data, these sites do not appear to pose a current threat to human health and the environment. Therefore, EPA is not requiring further action at this time.
