The U. S. Environmental Protection Agency (EPA) has received the analytical results from the 1998 groundwater sampling event of the monitoring wells MW-1A and MW-1B, performed by Converse Consultants at the Indian Health Service (IHS) hospital, located in Owyhee, Nevada on land of the Duck Valley Shoshone Paiute Tribe. The analytical results indicate that continued natural attenuation is taking place, which has brought groundwater contaminants to below action levels.

The information submitted has assisted EPA in assessing the status of this site, where one underground storage tank (UST) was removed on October 16, 1991. This site does not appear to pose a current threat to human health and the environment. EPA is not requiring further action at this time.
