This correspondence refers to the Fort Courage site, located in Houck, Arizona, on land of the Navajo Nation. In a letter dated September 2, 2004, EPA and the Navajo Nation EPA (NNEPA) required, prior to closure of this site, the sampling and laboratory analysis for hydrocarbon contamination of the existing drinking water well located on the property.

The analytical results for the well water samples collected at the UST site indicate no hydrocarbon concentrations above appropriate EPA, Region IX or NNEPA cleanup levels for drinking water. The information submitted has assisted EPA and NNEPA in assessing the status of this site, where four USTs were removed, and one UST was abandoned in place on March 17, 2003. Based on this data, this site does not appear to pose a current threat to human health and the environment. Therefore, EPA and NNEPA are not requiring further action at this time.
