This correspondence refers to the underground storage tank (UST) removal report prepared by Applied Engineering and Geology, Inc. for two USTs located at 7601 North State Street in Redwood Valley, California. This 14-acre site has been purchased by the Coyote Valley Band of Pomo Indians. The removal of the USTs and any associated remedial action were required by the Bureau of Indian Affairs prior to processing the application for the conversion of this private land into trust land.

Provided that the recommendations made in section 6.3 of the above-named closure report are implemented, EPA agrees with the North Coast Regional Water Quality Control Board that no further action is required at this site.
