The U. S. Environmental Protection Agency (EPA) has received the analytical results from soil samples taken at the Gila River Farm site. Soil contamination encountered during the removal of four underground storage tanks (USTs) has been remediated by land farming to below action levels.

The information submitted has assisted EPA in assessing the status of this site, where four underground storage tanks (USTs) were removed on October 15, 1997. This site does not appear to pose a current threat to human health and the environment. EPA is not requiring further action at this time.

If new USTs are installed at the site, Tank Notification Form # 7530-1 must be completed and sent to this office within 30 days after startup of the new UST system. A copy of this form is enclosed for your information.
