



# EPA National Geospatial Data Policy (NGDP) Stewardship Agreement

This agreement sets forth an accord between EPA's Office of Environmental Information (OEI) and Region 3, Office of Environmental Information and Analysis (participating organization's name) to fulfill the roles and responsibilities listed in EPA's NGDP Procedure for Geospatial Metadata Management. By signing this document, each party is agreeing to commit personnel and resources sufficient to perform the responsibilities listed for the roles assigned for their organization.

## Goals

The goal of the NGDP Procedure for Geospatial Metadata Management is to establish effective geospatial metadata lifecycle management by outlining common requirements and responsibilities for maintaining geospatial metadata used by EPA programs. This agreement ensures the fulfillment of roles identified in the NGDP Procedure for Geospatial Metadata Management in order to guarantee that associated responsibilities are carried out consistently across multiple EPA organizations.

## Resources

1. EPA's OEI commits to providing resources in the form of geospatial infrastructure, personnel, training and assistance to support organizations in fulfilling the Geospatial Data Owner, Geospatial Data Steward and GDG Steward Roles.
2. EPA's OEI agrees to provide sufficient personnel and resources to fulfill the roles of Geospatial Metadata Coordinator and GDG Administrator. All responsibilities required for those roles will be satisfied by OEI personnel and/or subcontractors.
